



LOBO Configurator Visio Files

LOBO Configurator© will allow the user to create simple or complex LOBO Systems configurations using Microsoft Visio.

Microsoft Visio must be purchased separately and does not form part of these instructions.

LOBO Configurator© is targeted at maintenance, process and engineering personnel, to enable accurate presentations and visualisations to be created. Users will be able to custom design millions of different configurations quickly and easily using only a basic knowledge of Visio.

LOBO Configurator© is intended to be used only as a graphical illustration presentation tool. No designs are warranted to be safe, correct or valid and no representations of any kind are made. LOBO recommends this product to be used in conjunction with the latest version of the LOBO catalogue and training videos and only by competent and trained persons.

Instructions for use.

Install Microsoft Visio and copy all the LOBO Configurator© files to your My Shapes directory. In the My Shapes directory, open one of the template files from the Templates directory:

Large, Medium or Small, depending on the complexity and size of your intended illustration. We have scaled each template to allow for this.

The LOBO stencils are attached to the templates and will be ready to start the illustration. Simply drag and drop components onto the template to commence your illustration.

Each LOBO component is isometric in orientation so choose the component first from the stencil and then choose the degree of orientation. Drag and drop to add to your design.

Most components have connection points identified by blue asterisks, which makes aligning the parts easy. Select the component and hover over the one you want to connect to. A red box will appear when the component is in the right place and a connection can then be made.

Microsoft Visio uses a layering system to assemble your illustrations. By right clicking on a component, and selecting Shape, you can bring the component to the front or back of a design. This will make your design look much more realistic.

It is a good idea to save your illustration as a .jpg file as well as a Visio .vsd file.

Bill of Materials.

When you have completed your design, click on Data and then Reports. Click on BOM and in the next window click Excel and click Run.

This will launch Excel and provide an itemised list of Lobo components.

Printing.

The LOBO templates have been set up to print on standard A4 paper, you may need to adjust the paper size to suit your requirements and obtain the best results.

All errors and omission are accepted by the user.
